MEMORANDUM FOR 375 AMW/CC

SUBJECT: Restriction of Movement and Testing after OCONUS Travel to Scott Air Force Base

1. The Coronavirus Disease 2019 (COVID-19) continues to present risk to Scott AFB as personnel travel to and from different locations. In order to reduce this risk, a restriction of movement (ROM) has been applied to inbound personnel to Scott beginning on their OCONUS departure date.
2. Redeployers from OCONUS locations are subject to a 10 day ROM, and also require testing between day 3 and 5 of their return. Personnel or their Unit Deployment Managers should request testing by utilizing attachment 1, COVID-19 Test Request Form.
 - a. Individuals who are fully vaccinated are exempt from ROM, but still subject to the testing requirement.
 - (1) Fully vaccinated is defined as 14 days after your second dose of a Pfizer or Moderna vaccine, or 14 days after your single dose of a J&J vaccine
 - b. Individuals recovered from laboratory-confirmed COVID-19 infection within previous 90 days are exempt from ROM and testing.
3. Non-deployment travel from OCONUS locations requires a 14 day ROM, and also require testing between day 3 and 5 of their return. Personnel should request testing by utilizing attachment 1, COVID-19 Test Request Form.
 - a. Individuals who are fully vaccinated are exempt from ROM, but still subject to the testing requirement.
 - (1) Fully vaccinated is defined as 14 days after your second dose of a Pfizer or Moderna vaccine, or 14 days after your single dose of a J&J vaccine
 - b. Individuals recovered from laboratory-confirmed COVID-19 infection within previous 90 days are exempt from ROM and testing.
 - c. Unit Commanders may reduce the 14 day ROM to a 10 day ROM with a risk assessment. Attachment 2, COVID-19 Travel and Risk Assessment Tool, provides guidance on implementing a 10 day ROM vs. 14 day ROM.

4. Attachment 3, SAFB Testing and ROM Guide, summarizes travel scenarios and associated COVID-19 mitigation requirements.
5. This policy applies to all personnel (Service member, DOD Civilian, and Contractors) traveling on official business or for leisure. Regardless of the length of the ROM, IAW CDC guidelines, individuals in ROM are expected to:
 - a. Self-monitor daily for fever and symptoms of COVID-19 for the full 14 days
 - b. Restrict movement to absolutely essential trips only
 - c. Avoid contact with others and always wear a face mask when in public
 - d. Practice social distancing of six feet or two meters
 - e. Keep contact limited to essential business and avoid all work/school environments
 - f. Stay out of public areas (i.e.mass transit, house hunting, large venues, etc)
