PUBLIC COMMENT PERIOD FOR PROPOSED PLAN AT SCOTT AFB

The United States Air Force (USAF) invites you to review and comment on the Proposed Plan (PP) for the preferred alternative of No Further Action (NFA) for Installation Restoration Program (IRP) Site UK510 at Scott Air Force Base (AFB), Illinois.

A Remedial Investigation/Feasibility Study (RI/FS) was finalized in June 2022 for UK510. The RI portion of the RI/FS provided a summary of the site history which included RI results from 2012, 2017, and 2021. An RI Addendum was finalized in March 2025 to revise evaluation of the future construction/excavation worker scenario. The Baseline Human Risk Assessment (BHRA) and Screening Level Ecological Risk Assessment (SLERA) included in the RI/FS and revised by the RI Addendum concluded no unacceptable risks to human or ecological receptors from exposure to sediment, subsurface soil, and surface water at UK510. The RI Addendum and PP both recommended NFA for UK510 and future monitoring under the purview of the Scott AFB Environmental Compliance Office. The recommended alternative is technically and administratively feasible, protective of human health and the environment. The USAF has selected the preferred alternative for UK510 and the Illinois Environmental Protection Agency concurs with USAF's selection.

The formal comment period for UK510 starts on June 6, 2025 and ends on July 8, 2025. Written comments will be accepted at any time during the formal comment period. Additionally, the USAF will hold a public meeting from 6 to 7:30 p.m. on June 18, 2025, to discuss the PP for UK510. The meeting will be held at the O'Fallon Public Safety Building, 285 N. Seven Hills Road, O'Fallon, Illinois, 62269.
